Terms & Conditions

- 1. The promotion period: from 1 July 2025 to 30 August 2025 (both dates inclusive).
- 2. The offer is applied to OCBC Macau cardholders except Business Platinum Card, VISA Debit Card and Web Dollar.
- 3. During the promotional period, customer purchase with OCBC Macau credit card at either "New Yaohan" (Nam Van store) or "NY8 New Yaohan" (Grand Lisboa Palace store) accumulating a total of MOP 1,500 on the same day, can redeem a MOP50 New Yaohan cash coupon ("Reward"). Each transaction must be MOP 200 or above, and must be purchased by same credit card; a maximum of 2 credit card receipts can be accumulated from different merchants. The transaction amounts at "New Yaohan" and "NY8 New Yaohan" cannot be combined.
- 4. During the entire promotional period, each eligible credit card can redeem rewards a maximum of 5 coupons.
