During Phase 1 or Phase 2, customers who use an OCBC Macau credit card to make a single spending transaction of MOP 1,000<sup>#</sup> or above at local dining identified by the Bank's system (hereinafter referred to as an "Eligible Transaction"), and whose accumulated spending amount\* in the month of the eligible transaction (i.e. May or June) reaches MOP 3,000 or above, shall, in addition to the original basic reward points/cash rebate applicable to the Eligible Transaction, be entitled to the following additional rewards:

<sup>#</sup>"Local restaurants" refers to dining transactions (except food delivery platform) in Macau with a valid transaction record on restaurant card machine, and it will be determined as a qualified transaction based on the merchant's acquiring bank's category code. Transactions made outside Macau or in currencies other than Macau Pataca will not be considered as qualified transactions.

\*Accumulated spending excludes transactions of gambling transactions, instalment plan payments, automatic contributions for funds/stocks, auto-debit amounts, reward point redemption for gifts, purchases of tickets/dining vouchers/gifts through the Bank, cash advances, handling fees, finance charges, or late payment charges.

4. During promotion period, each customer can earn up to 80,000 bonus points/\$400 cash rebate. Spending and rewards from the principal card and supplementary card will be combined and calculated. Spending the same cardholder using different credit cards will not be combined.
5. Customers do not need to register for this promotion. Bonus point/cash rebate will be credited into the respective card account upon fulfilling the spending of designated amount on or before July 31, 2026, and the cash rebate reward will be shown on the next monthly statement.
